If any area or portion of the turf substantially changes, as distinguished from a change in texture, or if pile heights decrease 50% or more within fifteen years after its initial installation, Southwest Greens International will have all such areas or portions replaced with new turf of equivalent quality, excluding installation costs. Southwest Greens International also warrants that at the time of the initial turf installation, the synthetic turf will be free of manufacturing defects. Slight color changes will occur over the lifetime of this turf/carpet and is not considered an issue or basis for claim. All labor cost involved with the removal of the affected turf/carpet and reinstallation of the replacement will be the responsibility of the purchaser.
